About the company

The challenge

The growing market of high-value foreign nationals purchasing property in the UK was a huge opportunity for Mishcon de Reya. The highest interest had been received from the growing economic nations of China and Russia.

To encourage potential foreign buyers to use their legal services, the decision was made to translate their English language UK Tax Guide into the native languages of their target markets:

- Russian
- Simplified Chinese
- Traditional Chinese

The solution

- When Mishcon de Reya approached Global Lingo about this project, we suggested linguists who were specialist lawyers or had paralegal backgrounds, due to the specific legal details contained in the guides.
- ▶ This approach ensures a greater level of accuracy and guarantees the correct terminology in the target language is used throughout, with a tone and style pertinent to the jargon used in these types of documents.
- We assembled test pieces in each of the language combinations from our pool of vetted linguists and submitted these to Mishcon de Reya's in-house review team. From this pool, they selected the linguists that best suited the tone and style they required.
- In addition to the translation aspect of this project, we also handled the Desktop Publishing elements. The source documents were supplied to Global Lingo as InDesign files, and our file engineers extracted the text for the linguists to work on.
- Post-translation these files were then typeset to resemble the look and feel of the English Guide version. With both Russian and Chinese, it is particularly important to ensure the flow of sentences and the document structure align as copy can be heavily shortened once translated.
